Building a World-Class Group Moving Towards a Powerful Country in Materials

Those who can succeed must be strong, and those who are self-reliant must be able to succeed. Promoting our ambition with technology, we are committed to enhancing our technological innovation capacity.

In a year when the old growth drivers are transforming into new ones at a faster pace, innovation is playing a stronger role as the primary driver. We have accelerated efforts to create sources of original technologies and innovated and implemented eight reform measures such as the "open competition mechanism" and the "seed" fund. We have actively declared as a leader of the modern industrial chain of low-carbon inorganic nonmetallic materials. Technological breakthroughs have been achieved in high-efficiency grinding of cement raw material, oxygen-fuel combustion coupled with carbon capture, ultra-fine electronic fiberglass, and one-time forming of flexible glass. Remarkable results have been achieved in the joint research on domestic large aircraft and aero-engines. Many new materials have been applied to major national tasks such as aerospace. In 2022, five innovations of the Group were listed in the Catalogue of Recommended Achievements of Technological Innovation of Central Enterprises, and 72 new high-tech enterprises were added, with a total of 22,000 effective patents, accelerating the realization of high-level technological self-reliance.

In 2022, the Group achieved revenue of RMB 380.16 billion, total profit of RMB 26.58 billion and net profit of RMB 22.11 billion. The Group was awarded "Double A" in the business performance appraisal of SASAC, and was rated as an enterprise with excellent performance, moving forward firmly on the road of high-quality development.

To achieve success, one should let others succeed and enjoy the benefits. Building righteousness with responsibility, we continuously improve brand leadership.

As the only central enterprise in the building material industry in China, we have always fulfilled our responsibility as "the backbone of a big country". As the vanguard of the "dual carbon" action in the building material industry, we have cooperated with 26 units to build the first dual carbon public service platform in the national raw materials industry, and carried out joint research on the dual carbon key & core technologies in building materials and other industries. We have continuously optimized the energy consumption structure and accelerated the planning of green and low-carbon demonstration projects and green energy projects. As a practitioner of promoting common prosperity, in accordance with the "Four No-Picks" requirements of the CPC Central Committee, focusing on the objectives and tasks of the "Five Revitalizations", we have constantly innovated the assistance mode, implemented more than 600 assistance projects in total, and sent 94 assistance cadres successively to effectively link the achievements of poverty alleviation with rural revitalization. In 2022, the brand image of the Group became more distinct, rising to 249th place in the Top 500 Most Valuable Global Brands, and fifth place among Chinese enterprises in the Social Responsibility Development Index. 

The Group is the largest supplier of cement, ready-mixed concrete, plasterboards, fiberglass, wind turbine blades, cement & glass and engineering technical services. It is also one of the leading producers of many new materials, such as ultra-thin electronic glass, high-performance carbon fibers, lithium battery separators and ultra-high voltage electrical porcelain.





The production scale of cement and commercial concrete ranks first in the world, with 379 new dry process cement production lines, clinker capacity of about 300 million tons, cement capacity of over 500 million tons and commercial concrete capacity of about 400 million cubic meters. As the standard configuration for the city, 51 cement kiln cooperative disposal production lines have been built. The total annual disposal scale is 5.33 million tons, and the landfills are reduced by 1,333 mu. The installed capacity of waste heat power generation of cement sheeting is 1971.3 MW.

Plasterboards and Waterproof Materials



Focusing on plasterboard business, we develop the business of "plasterboard+" supporting systems, and serve national key projects such as the Great Hall of the People, the Olympic Games and the Winter Olympics. We promote the global original "Luban" universal board whole house assembly system, and actively develop waterproof materials and coatings that can be installed and brushed immediately and allow immediate occupancy, creating a low-carbon, environment-friendly and healthy indoor environment. Taking plasterboards as the leading product, we have gradually developed the global layout of the whole product lines.

F Fiberglass



The production capacity is 3.5 million tons, ranking first in the world. The fiberglass tank furnace wiredrawing technology won the second prize of National Awards for Scientific and Technological Progress. We have created the first large-scale tank furnace wiredrawing production line in China, the first 10,000-ton fiberglass production line in China and the first large-scale fiberglass production line overseas, with a global market share of over 30%.

The production capacity is 30 GW, and the products cover the series from 1.0 MW to 12.0 MW, with more than 100 models, which are sold to the United States, Thailand, Pakistan, South Korea and other countries. We have developed the longest 90 m 6 MW carbon fiber girder composite blade in China and the largest 102 m 11 MW all-fiberglass offshore blade in China, creating many of the best in China.

The autonomous and controllable high-end carbon fiber complete technology won the first prize of 2017 National Awards for Scientific and Technological Progress. The first Xining 10,000-ton carbon fiber production base in China was put into use, marking the industrialization of domestic carbon fiber. We participated in the formulation of the first international standard for measuring carbon fiber density in China.

With internationally advanced wet separator manufacturing equipment and leading technology R&D capabilities, we have realized the domestic production of the last key material in lithium battery materials. We have 5-20 μm wet separator and various coated separator products, which are used in new energy vehicle power batteries, 3C consumer batteries, energy storage batteries and other fields, helping China achieve the goals of carbon peaking and carbon neutrality at an early date.

We have achieved a series of industrialization achievements that are "the first in China and the best in the world". We have independently built the world's largest single-unit oxygen-fuel combustion photovoltaic glass production line, and the first thin and high-transmittance photovoltaic glass intelligent production line in China. We have successfully rolled out the world's first large-area cadmium telluride power glass. The photoelectric conversion rate of copper indium gallium selenium power glass has set a new world record. The world's largest single-unit thin film BIPV application demonstration project has been built and applied in multiple scenarios. We have independently developed China's first neutral borosilicate pharmaceutical glass tubes for vaccines and achieved stable mass production. We have completed the layout of high-end platforms such as the only national new glass material innovation center in the industry, and achieved a stable market share of over 90% in the global high-end glass engineering.

Advanced Ceramics and Artificial Crystals



Advanced Ceramics is the third enterprise in the world after CoorsTek of the United States and Toshiba of Japan, and the first and only enterprise in China to form mass production of hot isostatic pressing silicon nitride ceramic materials. The successfully developed G3 bearing balls have been applied in aerospace and aviation engineering, and have been supplied in large quantities in many domestic bearing enterprises. The preparation technology of nonlinear optical crystals, infrared optical materials and microcrystalline materials has generally reached the international advanced and domestic leading levels. The nonlinear optical crystal KTP has helped realize the core functions of the "Mozi" quantum communication satellite, providing crystal material support for China to lead the world in quantum communication development.

FF Engineering and Technical Services



With nearly 500 cement and glass engineering projects built at a high level in the world, we are the largest Chinese-funded photovoltaic EPC general contractor in Europe, one of the few enterprises with complete industrial chain in the international cement technology and equipment engineering market, and the largest cement technology and equipment engineering system integration service provider in the world.

It also adheres to the concept of "Price, Cost and Interest", focuses on cost control, establishes cost benchmarks, strengthens cost management, plans expenses, and fully does the target dismantling and task inversion. On the production end, the "One Cent" cost saving plan is fully implemented, that is, the production cost of gypsum board per square meter is reduced by 10 cents year-on-year in the gypsum board business. On this basis, the "One Cent" cost saving plan is extended to other business areas. In 2022, the unit consumption of gypsum, face protection paper and energy of gypsum board products decreased year on year, and the production cost decreased by about 10 cents year on year. Beixin Waterproof's cost is reduced by 5.6%, Beixin Coating' s cost is reduced by 5.61%, and the annual cost of the company is saved by 332 million yuan.



Management Refinement

CNBM effectively promotes digital transformation, refined operation and management, and business integration, and does a good job of empowering system process reconstruction to promote continuous improvement of efficiency and more robust operation. In 2022, the Group formulated an implementation plan to speed up the construction of worldclass enterprises, and made every effort to build a world-class enterprise with global competitiveness with excellent products, outstanding brands, leading innovation and modern governance. China Jushi Co., Ltd. through the implementation of "12350 Quality Management Method", continuously explores the whole process of the value chain such as production, supply, sales

In the three-year action of state-owned enterprise reform

we deeply promoted the reform, went all out to tackle the hardest tasks, fully completed the task of the three-year action of state-owned enterprise reform, carried out supervision and inspection on 16 important subsidiaries, ensuring that the reform effect can stand the test, and seriously summarized the experience. CNBM was selected as the third batch of advanced models of "Learning from the Advanced, Grasping Implementation and Promoting Reform" of the State Council Leading Group Office of State-owned Enterprise Reform, and exchanged experiences with SASAC six times.

Notable results have been achieved in three institutional reforms

- With a rigid fulfillment of performance in 2021. Nine unqualified employees were withdrawn
- The proportion of managers competing for posts exceeded 60%, and the proportion of last-class adjustment and incompetent withdrawal reached 2.38%.
- New overseas investment projects were added, and the "toolbox" for mediumand long-term incentives was expanded to 5 categories and 9 types, and 9 new enterprises and 738 key employees were added to implement a full level contractbased management tenure system for medium- and long-term incentives.

- The Group and Sinoma Energy Conservation Ltd. were selected as "Model Enterprises of Corporate Governance" by SASAC, and the Group was rated as "Excellent" in the construction evaluation of SASAC Board of Directors.

Reform of state-owned capital investment companies

Taking the formal transformation of the Group into an investment company as an opportunity, we have accelerated the optimization of the layout and structural adjustment of state-owned capital, and made multi-directional efforts in the integration of basic building materials, new materials, engineering and technical services, logistics and trade, making the leading industries more elite.



We increased our holdings of five listed companies, namely China National Building Material Co., Ltd., Pingliang Qilianshan Cement Co., Ltd., Ningxia Building Materials Group Co., Ltd., China Testing & Certification Internationa Group Co., Ltd. and CNBM Triumph Mineral Resources Group Co., Ltd., to stabilize the stock prices, increase the market value and boost investor confidence.



We adhere to the corporate mission of "creating a better world with materials", focus on the "Four Aspects", fully leverage the role of the "national team" of scientific and technological innovation, and form a strong synergy of high-level scientific and technological self-reliance by increasing investment in R&D, improving the system and mechanism of scientific and technological innovation, strengthening the training of scientific and technological talents, and gathering innovative resources.

Improve Institutions and Mechanisms

We insist on opening the way for scientific and technological innovation and creating a good environment with perfect systems and mechanisms. In 2022, we continued to increase investment in technology R&D, implemented innovative measures such as the "3+22" research task, "the open competition mechanism" and special funding of "331", and allocated the first batch of special "seed" funds of RMB 114 million to guide scientific research and motivate scientific and technological personnel, driving enterprises to selfraise RMB 1.55 billion. At the same time, the Measures for Performance

and industries, deeply exploring cooperation opportunities and modes. China Building Materials Academy cooperated with the innovation forces within the Group to take the lead in implementing the construction tasks of low-carbon cement and special functional materials, striving to occupy the commanding heights of low-carbon cement science and technology, and making every effort to cultivate strategic products, industries and industrial chains of special functional materials.

External Joint Research

We deepened our cooperation with Commercial Aircraft Corporation of China, Ltd., and aimed at the major strategic needs of large aircraft and other countries, promoting the special project of large aircraft composite materials, and obtaining the supplier qualification of three fuselage sections of CR929 large aircraft. We focused on hydrogen energy storage and transportation materials, carbon fiber composite materials and low carbon technology, carried out joint research with Chinese Academy of Sciences, China Petroleum & Chemical Corporation, China Aerospace Technology Group Co., Ltd., etc. to build a national "entrepreneurship and innovation" base for artificial crystals, and more than 20 upstream and downstream enterprises have settled in the base, forming a coordinated development system of the industrial chain. The National We cooperated with Shandong University Manufacturing Innovation Center for New Glass Materials has gathered 80 enterprises, colleges and universities and other innovation subjects and production enterprises, forming a "one-stop" market-oriented and industrialized chain from glass R&D to design to engineering.

Nanjing Fiberglass Research & Design Institute: The advantages of **F** school-enterprise cooperation are constantly highlighted.


In response to the needs of industry and national policies, Nanjing Fiberglass Research & Design Institute has actively cooperated with universities such as Tsinghua University and Donghua University in production, education and research. In recent years, it has undertaken seven scientific research projects such as national science and technology support plan, national key special projects and national defense supporting facilities. According to different working conditions, it has developed different surface modification formulations and treatment technologies, improved the temperature resistance, corrosion resistance and oxidation resistance of substrates, and formed a series of ultra-low emission technologies and products. The R&D project Collaborative Deep Treatment Technology and Application of Industrial Flue Gas Multi-pollutants in cooperation with universities won the first prize of national scientific and technological progress, and the Key Technology and Industrialization of Macro Preparation of High Curvature Liquid Level Electrostatic Spinning Nonwovens won the second prize of national technological invention.



Promoting Digital Transformation

Driven by "Digital Leading Material Creation", we make every effort to build "Digital China Building Materials" which are "efficient, collaborative, shared, intelligent, green and ecological". In 2022, we issued guidelines on the principles of information construction and digital transformation, and built three special information systems for the Group's leadership cockpit, organization and bidding and procurement. We built the world's leading fiberglass "Future Factory" and release the 1.0 standard of intelligent cement plants. The first phase of the Group treasury management and control platform was completed and launched, and the visibility rate of domestic accounts was 100%. The data center of the Group's Internet Industrial Park started construction, the "No.1 Project" of New Tianshan Cement was steadily implemented, and the construction of the Internet data center of Ningxia Building Materials Group Co., Ltd. was promoted in an orderly manner. China Jushi: The first in the industry and the world! China Jushi's **F** intelligent manufacturing base is fully completed

On November 2, 2022, the completion ceremony of China Jushi's intelligent manufacturing base was held in Tongxiang Development Zone, Zhejiang Province, marking that China Jushi's intelligent manufacturing base, which took 5 years to build, has been fully completed and achieved the expected output with high efficiency and quality. In 2017, China Jushi invested over RMB 14 billion to start the construction of intelligent manufacturing base of Tongxiang Headquarters. Nowadays, four superlarge reinforced fiberglass production lines and three super-large electronic fiberglass production lines have been completed in Tongxiang Headquarters, forming an annual production capacity of 600,000 tons of reinforced yarn and 800 million meters of electronic cloth. The strategy of "rebuilding a Jushi" has been completed perfectly. The operation of the base has also made China Jushi rank first in the industry and the world in various major production technology indicators such as capacity scale, production efficiency, production cost and quality control, becoming the "future factory" and "lighthouse factory" leading global fiberglass manufacturing.

In 2022, the Group built a composite materials digital simulation platform for civil aviation, and delivered the first batch of C919 passenger and cargo cabin floors. The 8-meter level fuselage panel of CR929 wide-body passenger aircraft was successfully developed, and the first flight installation parts of CJ1000A turbofan blades were delivered. It newly undertook 7 major research tasks such as large aircraft composite materials, high-performance carbon fiber and high-level radioactive nuclear waste liquid treatment, as well as 9 national key research and development projects during the 14th Five-Year Plan period. A large number of new materials were used in national major projects such as the Mengtian space lab module, Shenzhou-14 and Tianzhou-4. The construction of the low-carbon inorganic nonmetallic material industry chain of the Group is progressing smoothly, and China Jushi has won the China Gold Patent Award.

Harbin FRP Institute: Support "Daoda Constellation" ► The "Anxi Tieguanyin-2" satellite was successfully launched

At 11:30 on April 30, 2022, China successfully launched the "Daoda Constellation" and "Anxi Tieguanyin-2" satellites (including five satellites in total) in the East China Sea with the Long March 11 sealaunched remote three carrier rocket. The satellites successfully entered the scheduled orbit and the launch mission was a complete success. Harbin FRP Institute participated in the development and production of composite components such as the main load-bearing structure and light shield of "Daoda Constellation" satellite, and also participated in the production of composite components. At the same time, Harbin FRP Institute participated in the design of all composite components in the "Anxi Tieguanyin-2" satellite camera and some composite components in the satellite, and provided a lot of development experience and schemes in the design of composite components. During the production, it optimized the molding process, broke through the technological difficulties, and finally realized the integrated molding of carbon fiber composite thin-walled special-shaped components, meeting the requirements of low weight, high load and high precision.

China United Cement Linyi: Photovoltaic power contributes **T** to the green development of enterprises

Electricity is an important energy source for enterprises producing cement products. In the face of rising coal prices, increased costs, and reduced profits, China United Cement Linyi invested RMB 60 million to build a 6.5 MWp distributed photovoltaic gridconnected power station on the basis of the existing low-temperature waste heat power generation of cement kiln. This can generate 10 million kWh of electricity and reduce carbon dioxide emissions by about 5,703 tons throughout the year. In addition, investment has been made in the construction of photovoltaic power generation sheds with an annual power generation capacity of about 300,000 kWh in living areas and office areas, as well as the construction of a floating fishing and light complementary photovoltaic power generation system with an annual power generation of about 50,000 kWh was built in the pond of the factory. The method of "connecting to nearby power sources, generating electricity for oneself, and selling excess electricity to the power grid" was adopted, greatly reducing the cost of electricity purchased by enterprises, promoting clean production and low-carbon production, and producing great value in economic benefits and environmental protection.




Concept of Responsibility



Production Capacity of Cement from 2012 to 2022






